## 2. Principles

- **2.1.** The controller is Karin Hauenstein-Schnurrer.
- **2.2.** It is particularly important to us to protect and securely store all personal data that you entrust to us. In this document, you will learn more about how we process your personal data.

### 3. Purpose limitation, legal basis, storage period and data recipients

- **3.1** We require the collected personal data for the production of marketing materials for the respective client as well as for the copywriting of magazines, press releases and reports. The data is collected, stored, processed and used for this purpose.
- **3.2** The legal basis for the processing of your personal data is, on the one hand, contract fulfilment, legitimate interests, the fulfilment of our legal or contractual obligations and, on the other hand, your consent. Failure to provide the data may have various consequences.
- **3.3** We also process data that we have legitimately received from our customers or clients. This is basic personal data such as name, address, telephone number and e-mail address.
- **3.4** We process your personal data (name, address, telephone number and e-mail address), if necessary, for the duration of the entire business relationship (from the initiation, processing to the termination of a contract) and beyond in accordance with the statutory retention and documentation obligations arising from the Austrian Commercial Code (UGB), the Federal Fiscal Code (BAO) and until the end of any legal disputes, ongoing warranty and guarantee periods, etc.



#### 4. Contact form

- **4.1.** Your details, including personal data from our contact form, will be processed and stored by us in order to deal with your enquiry. This data will not be collected or passed on without your consent. We cannot process your enquiry without this data.
- **4.2** Data processing is carried out on the basis of the legal provisions of § 96 para. 3 TKG and Art 6 para. 1 lit a (consent) DSGVO.

## 5. Consent and right to cancellation

- **5.1** If your consent is required for the processing of your data, we will only process it after you have given your express consent.
- **5.2** In principle, we do not process data of minors and are not authorized to do so. By giving your consent, you confirm that you have reached the age of 14 or that you have the consent of your legal representative.
- **5.3.** You can revoke your consent at any time by sending an e-mail to office@lt-holding.at. In such a case, the data previously stored about you will be anonymized and subsequently only used for statistical purposes without personal reference. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

## 6. Your rights
